**IMPORTANT INSTRUCTIONS TO CANDIDATES**

- **The Counselling for admission to UG Courses for the year 2026-27 will be done by CAPASC, Karaikal**
- **The application form and instructions will be available for access via online ([www.capasckkl.in](http://www.capasckkl.in)) from 15.05.2026**
- **The candidate seeking admission must apply online through [www.capasckkl.in](http://www.capasckkl.in) website as per the schedule notified. Registration after the due date will not be entertained.**
- **The candidate shall comply with all the instructions while filling in the application form.**
- **Read the instructions carefully, fill-in the application via online and take a printout of it.**
- **The candidates seeking admission to any under graduate course must have completed H.Sc. or from any recognized Board and must have passed in all subjects at the time of admission. For Lateral Entry admissions, Diploma certificate with first class Qualifications is required.**
- **Admission is based on valid H.Sc. Academic Marks and Reservation Criteria of Government of Puducherry.**
- **Please note that the candidature is subject to fulfilling the minimum eligibility requirements prescribed for applying to the**

**concerned programme of study. In case a candidate does not meet the minimum eligibility criteria prescribed for applying to the concerned programme, it will be deemed to be done at the candidate's own risk and cost if at any stage, it is found that if the minimum eligibility requirements are not fulfilled, the admission if granted, shall be cancelled post facto and the fees paid, if any, shall not be refunded in any case.**

- **CAPASC, Karaikal will carry out only the allotment of seats through counseling. The admission is subject to the approval of the Pondicherry University as per the norms.**
- **The various terms and conditions mentioned in the Information Brochure are subject to the change made in the rules and regulations by the Government of Puducherry and affiliating University from time to time as per the directions of the Pondicherry University. CAPASC reserves the right to revise, amend, update or delete any part of this brochure, as and when considered necessary.**

- **For all the legal matters regarding CAPASC admissions, the jurisdiction will be the High Court of Chennai only.**
- **For all the legal matters regarding any dispute against Pondicherry University, the jurisdiction will be the High Court of Chennai only.**

- **Submit the online filled-in application with the self-attested photocopies of the necessary certificates in person or by post to Arignar Anna Government Arts and Science College, Karaikal-609605.**
- **Candidates applying for two colleges shall submit Only One Application. Multiple applications will summarily be rejected.**
- **The last date for receipt of filled in Application Form along with necessary enclosures in person is 29.05.2026.**
- **Duly filled-in, downloaded and printed application form from [www.capasckkl.in](http://www.capasckkl.in) together with the self-attested photocopies of the necessary certificates can be directly submitted at Arignar Anna Govt. Arts & Science College under CAPASC by paying Rs.400/- (for SC /ST/PWD Rs.200/-) on or before 29.05.2026.**
- **The application can also be sent by post along with a Demand Draft to The Convenor, CAPASC, Arignar Anna Govt. Arts & Science College, Karaikal – 609 605 so as to reach on or before 06.06.2026 by 5.00 PM. (Demand Draft: Rs.300/- (for SC /ST Rs.150/-) should be drawn in favor of The Convenor, CAPASC, Karaikal.) on or before 05.06.2026.**
- **Candidates who have appeared for the supplementary examination should not wait for the results but submit the filled-in Application Form to The Convenor, CAPASC, Arignar Anna Govt. Arts and Science College, Karaikal – 609 605 on or before the last date. However, such candidates should submit the self-attested**

**photocopy of the mark statement of the supplementary examination within Five days from the date of issue of supplementary result.**

- **The final authority to settle disputes, if any, in any matter will be the Director, Directorate of Higher and Technical Education, Puducherry or any Authority appointed for this purpose.**
